


## PENEMUAN UTAMA

### Pendahuluan

Laporan ini membentangkan maklumat perangkaan getah daripada estet di Malaysia untuk 2009 yang dikumpul dari Banci Estet Getah Tahunan yang dijalankan pada 2010. Sebagai tambahan, maklumat kebun kecil yang diperoleh daripada pihak RISDA, FELDA, FELCRA and LGM turut dibentangkan dalam laporan ini. Maklumat yang dikumpul adalah merangkumi bilangan estet, keluasan bertanam, pengeluaran, guna tenaga, penggunaan domestik, stok, import dan eksport. Penunjuk utama yang terpilih untuk perangkaan getah 2007 dan 2009 serta peratus perubahan ditunjukkan di **Jadual 1**.

### Bilangan estet

Bilangan estet dalam negara terus mencatatkan trend menurun dan pada 2009, terdapat 185 estet iaitu pengurangan sebanyak 12 estet (-6.1%) berbanding 2007. Data siri masa bagi bilangan estet di Malaysia bagi tempoh 2000-2009 ditunjukkan dalam **Carta 1**.

## MAIN FINDINGS


### Introduction

*This report presents information on rubber statistics from estates in Malaysia for 2009 which was compiled from the Annual Census of Rubber Estates conducted in 2010. In addition, information of smallholdings obtained from RISDA, FELDA, FELCRA and MRB are also presented in this report. The information collected include the number of estates, planted area, production, employment, domestic consumption, stocks, imports and exports. The selected main indicators for rubber statistics 2007 and 2009 as well as the percentage change are shown in Table 1.*

### Number of estates

*The number of estates in the country continued its downtrend and in 2009 there were 185 estates a reduction of 12 estates (-6.1%) when compared to 2007. The time series data on the number of estates in Malaysia for the period 2000-2009 is shown in Chart 1.*

## Keluasan bertanam

Bagi tempoh 2000 hingga 2009, keluasan bertanam juga menunjukkan trend menurun yang berterusan seperti ditunjukkan dalam **Carta 2**. Purata penurunan tahunan keluasan bertanam bagi tempoh ini adalah sebanyak 8,226 hektar.


Pada 2009, keluasan estet yang dicatatkan adalah 49,740 hektar iaitu berkurangan sebanyak 2,940 hektar (-5.6%) berbanding 2007. Pengurangan ini adalah selari dengan penurunan bilangan estet seperti yang ditunjukkan dalam **Carta 1**.

## Planted area

For the period 2000 to 2009, the planted area also continued its downtrend as presented in **Chart 2**. The average annual decline in planted area for the period was 8,226 hectares.

In 2009, the area for estates recorded 49,740 hectares which was a reduction of 2,940 hectares (-5.6%) when compared to 2007. This decrease was in line with the decrease in the number of estates as shown in **Chart 1**.

Chart 2: Planted area on estates, 2000-2009




Sebahagian besar keluasan bertanam getah diusahakan oleh pekebun kecil (95.1%) dan hanya 4.9 peratus oleh estet seperti ditunjukkan dalam **Carta 3**. Oleh yang demikian, pengeluaran getah asli oleh kebun kecil dan estet masing-masing telah mencatatkan 93.4 peratus dan 6.6 peratus (**Carta 4**).

## Pengeluaran

Jumlah pengeluaran getah asli yang dicatatkan pada 2009 berkurang sebanyak 340,638 tan metrik (-28.4%) kepada 857,562 tan metrik jika dibandingkan dengan 2007. Begitu juga, pengeluaran getah asli oleh estet turut mencatatkan penurunan sebanyak 8,701 tan metrik (-13.3%) jika dibandingkan 2007 (**Jadual 1.1**).

*Chart 3: Planted area by estates and smallholdings, 2009*




*The majority of the planted area for rubber were operated by smallholders (95.1%) and only 4.9 per cent by estates as shown in **Chart 3**. Consequently the production of natural rubber by smallholdings and estates were 93.4 per cent and 6.6 per cent respectively (**Chart 4**).*

## Production

*In 2009, the total production of natural rubber fell 340,638 tonnes (-28.4%) to 857,562 tonnes when compared to 2007. Similarly, production of natural rubber by estates also showed a decrease of 8,701 tonnes (-13.3%) when compared to 2007 (**Table 1.1**).*

## Guna tenaga

Jumlah keseluruhan pekerja yang bekerja di estet pada 2009 adalah seramai 11,081 orang dan daripada jumlah tersebut bilangan pekerja bergaji adalah seramai 10,428 orang dengan jumlah bayaran gaji & upah sebanyak RM109,149 juta. Data siri masa bilangan pekerja bergaji dan gaji & upah dari 2000-2009 adalah seperti ditunjukkan dalam **Carta 5**.


Purata gaji & upah tahunan seorang untuk 2009 adalah sebanyak RM10,467 dan RM9,661 bagi 2007. Walau bagaimanapun, bilangan pekerja berkurangan sebanyak 9.8 peratus berbanding 2007. Begitu juga dengan gaji & upah yang berkurangan sebanyak 2.3 peratus.

## Employment

The total number of persons engaged in estates for 2009 were 11,081 persons and from this number, paid employees totalled 10,428 persons with RM109,149 million disbursed as salaries & wages. The time series data for the number of paid employees and salaries & wages from 2000-2009 is shown in **Chart 5**.

The average annual salaries & wages per employee for 2009 was RM10,467 and RM9,661 for 2007. However, the number of workers decreased by 9.8 per cent when compared to 2007. Similarly, salaries & wages also declined by 2.3 per cent.

## Import


Pada 2009, jumlah getah asli yang diimport Malaysia adalah sebanyak 738,758 tan metrik. Ini menunjukkan peningkatan sebanyak 133,638 tan metrik (+22.1%) jika dibandingkan dengan 2007. Malaysia mengimport getah asli terutama dari Thailand (65.6%), Indonesia (7.7%), Viet Nam (5.0%), Filipina (4.0%), India (3.0%) dan Myanmar (2.6%). Import getah asli mengikut negara utama bagi 2009 adalah seperti di **Carta 6**.

## Imports

In 2009, Malaysia's imports of natural rubber totalled 738,758 tonnes. This showed an increase of 133,638 tonnes (+22.1%) when compared to 2007. Malaysia imported natural rubber mainly from Thailand (65.6%), Indonesia (7.7%), Viet Nam (5.0%), Philippines (4.0%), India (3.0%) and Myanmar (2.6%). Imports of natural rubber by major countries for 2009 is shown in **Chart 6**.

*Chart 6: Imports of natural rubber by major countries, 2009*




## Eksport

Eksport getah asli pada 2009 adalah sebanyak 697,562 tan metrik. Jumlah ini berkurangan sebanyak 320,490 tan metrik (-31.5%) berbanding 2007. Malaysia mengeksport getah asli kepada beberapa buah negara utama seperti China 39.0 peratus, Jerman 11.7 peratus, Rep. Korea 6.7 peratus, Rep. Islam Iran 4.6 peratus dan Amerika Syarikat 4.1 peratus. Eksport getah asli ke negara utama bagi 2009 adalah seperti di **Carta 7**.

## Exports

The total exports of natural rubber in 2009 was 697,562 tonnes, a decrease of 320,490 tonnes (-31.5%) when compared to 2007. Malaysia exported natural rubber to various countries with major destinations being China 39.0 per cent, Germany 11.7 per cent, Rep. of Korea 6.7 per cent, Islamic Rep. of Iran 4.6 per cent and United States of America 4.1 per cent. Exports of natural rubber to major countries for 2009 is shown in **Chart 7**.

## Penggunaan domestik

Pada 2009, jumlah penggunaan getah asli dalam negara adalah sebanyak 468,706 tan metrik iaitu bertambah sebanyak 18,460 tan metrik (+4.1%) berbanding 2007. Pertambahan ini adalah disumbangkan terutamanya oleh kenaikan penggunaan dalam industri sarung tangan getah.


Tiga industri utama yang menyumbang kepada jumlah penggunaan domestik pada 2009 adalah industri sarung tangan getah (67.6%), benang getah (12.4%) dan industri tayar dan tiub (7.9%). Perbandingan ketiga-tiga industri bagi 2007 dan 2009 ditunjukkan dalam **Carta 8**.

## Domestic consumption

In 2009, domestic consumption of natural rubber was 468,706 tonnes, an increase of 18,460 tonnes (+4.1%) when compared to 2007. This rise was attributed mainly to the increase of consumption in the rubber gloves industry.

The three main industries which contributed to total domestic consumption in 2009 were rubber gloves (67.6%), rubber threads (12.4%) and tyres and tubes (7.9%). The comparison for these three industries for 2007 and 2009 is shown in **Chart 8**.

## Stok

Paras stok yang dipegang pada akhir 2009, adalah sebanyak 161,222 tan metrik iaitu meningkat sebanyak 7,940 tan metrik (+5.2%) berbanding 2007. Sebahagian besar stok getah asli ini disimpan oleh pelesen (pemproses dan pengguna getah) iaitu sebanyak 99.8 peratus dan selebihnya oleh estet (0.2%).


Paras stok yang dipegang oleh pelesen dalam tempoh sepuluh tahun agak stabil manakala stok yang dipegang oleh estet menunjukkan trend menurun khususnya dari 2000 hingga 2005 dan 2007 hingga 2009 seperti **Carta 9**.

## Stocks

The level of stocks held at the end of 2009 was 161,222 tonnes, an increase of 7,940 tonnes (+5.2%) compared to 2007. The bulk of natural rubber stocks was held by the licensees (rubber processors and consumers) at 99.8 per cent and the balance by estates (0.2%).

The level of stocks held by licensees for ten-year period was quite stable whereas stocks held by estates showed a downtrend especially from 2000 to 2005 and 2007 to 2009 as shown in **Chart 9**.

## NOTA TEKNIKAL

<b>Pendahuluan</b>	Laporan ini memuatkan maklumat perangkaan estet getah yang diperoleh daripada Banci Estet Getah Tahunan bagi tahun rujukan 2010. Turut dipaparkan adalah data sekunder yang diperoleh daripada sumber seperti Pihak Berkuasa Kemajuan Pekebun Kecil Perusahaan Getah (RISDA), Lembaga Kemajuan Tanah Persekutuan (FELDA), Lembaga Penyatuan Pemulihan Tanah Persekutuan (FELCRA), Lembaga Getah Malaysia (LGM) dan pertubuhan antarabangsa seperti <i>International Rubber Study Group (IRSG)</i> .
<b>Objektif</b>	Objektif utama laporan ini ialah untuk memaparkan perangkaan getah yang berkenaan dengan keluasan bertanam, pengeluaran, hasil, guna tenaga, gaji & upah, import dan eksport getah serta untuk menyediakan perangkaan terperinci bagi estet getah. Perangkaan ini akan membantu kerajaan dalam perancangan pembangunan, penggubalan dasar termasuk pemantauan pembangunan industri yang berdasarkan getah. Perangkaan tersebut boleh juga digunakan oleh pihak swasta dan individu bagi tujuan membuat penyelidikan dan analisis ekonomi.
<b>Kuasa Perundangan</b>	Banci ini telah dilaksanakan di bawah Akta Perangkaan 1965 (Disemak 1989). Mengikut Akta ini, kandungan soal selidik yang diterima adalah sulit. Selaras dengan keperluan Akta ini, hanya angka aggregat diterbitkan.
<b>Skop dan liputan</b>	Banci ini meliputi semua estet getah di Malaysia. Sumber utama rangka banci ialah Suruhanjaya Syarikat Malaysia (SSM) dan Lembaga Getah Malaysia (LGM). Bagi Sabah dan Sarawak, sumber tambahan diperoleh dari Pejabat Daerah dan Pejabat Pertanian Daerah.
<b>Konsep dan definisi</b>	Konsep dan definisi yang digunakan adalah berasaskan kepada syor Pejabat Perangkaan Pertubuhan Bangsa-Bangsa Bersatu. Konsep ini mengikut amalan yang sudah diterima pakai dan dengan ini akan memudahkan perbandingan data dibuat di peringkat antarabangsa.

- i. Estet getah ditakrifkan sebagai:
  - a. semua kawasan, bersambungan atau berpecah-pecah dengan keluasan tidak kurang daripada 40.47 hektar (100 ekar), ditanam dengan getah atau di mana penanaman getah dibenarkan dan di bawah satu hak milik yang sah; atau
  - b. mana-mana keluasan tanaman getah yang telah pun wujud dalam estet kelapa, koko atau kelapa sawit.
- ii. Kebun kecil getah ditakrifkan sebagai yang meliputi semua kawasan, bersambungan atau berpecah-pecah, berjumlah kurang daripada 40.47 hektar (100 ekar), ditanam dengan getah atau di mana penanaman getah dibenarkan dan di bawah satu hak milik yang sah. Kebun kecil getah terdiri daripada tersusun dan tidak tersusun. Kebun kecil yang tersusun meliputi kawasan di bawah rancangan kerajaan seperti berikut :-
  - a. Lembaga Kemajuan Tanah Persekutuan (FELDA);
  - b. Pihak Berkuasa Kemajuan Pekebun Kecil Perusahaan Getah (RISDA);
  - c. Lembaga Penyatuan dan Pemulihan Tanah Negara (FELCRA);
  - d. Rancangan tanah Kerajaan Persekutuan yang lain; dan
  - e. Rancangan tanah Kerajaan Negeri.

**Tahun rujukan**

Tahun rujukan bagi Banci ini adalah tahun takwim 2009. Walau bagaimanapun bagi estet yang tahun kewangannya berbeza dengan tahun takwim, iaitu kurang daripada enam bulan, angka tahun kewangan diterima pakai sebagai mewakili tahun takwim.

**Metodologi**

Banci dilaksanakan secara mel dengan menggunakan borang soal selidik. Responden diberi tempoh satu bulan untuk melengkapkan dan mengembalikan borang soal selidik tersebut kepada Jabatan ini. Selepas itu, kerja luar dijalankan bagi mendapatkan borang lengkap daripada pertubuhan yang tidak memberi jawapan.

**Taraf sah**

Taraf sah sesebuah pertubuhan ditakrifkan seperti berikut:-

- i. **Hak milik perseorangan** merujuk kepada perniagaan yang dimiliki oleh orang perseorangan semata-mata untuk mendapatkan keuntungan. Pemilik mempunyai hak mutlak untuk mengendalikan urusan pertubuhannya.
- ii. **Perkongsian** merujuk kepada sekumpulan individu yang bersetuju untuk mengkontrak dan menjalankan perniagaan dengan matlamat untuk mendapat keuntungan. Perniagaan tersebut diuruskan oleh mereka atau salah seorang daripada mereka yang bertindak mewakili semua pihak. Perkongsian perniagaan ini hendaklah mengandungi sekurang-kurangnya dua orang dan tidak melebihi had maksima dua puluh orang.
- iii. **Syarikat Sendirian Berhad** merupakan sebuah perbadanan swasta yang ditubuhkan untuk menjalankan perniagaan dengan matlamat mencari keuntungan. Sahamnya dipegang secara tertutup oleh pemegang-pemegang saham yang mempunyai kawalan terhadap operasi syarikat. Ia didaftarkan dengan tanggungan berhad. Sesebuah syarikat sendirian berhad mempunyai Memorandum dan Artikel Persatuan sendiri, yang antara lain:
  - a. menghadkan hak untuk memindahkan sahamnya;
  - b. menghadkan bilangan pemegang sahamnya di antara dua hingga lima puluh orang (tidak termasuk pekerja syarikat itu dan bekas pekerja yang masih menjadi ahli);
  - c. melarang sebarang pelawaan kepada orang ramai untuk membeli apa-apa saham atau debentur syarikat itu; dan
  - d. melarang sebarang pelawaan kepada orang ramai supaya menyimpan wang di syarikat itu bagi sesuatu tempoh yang ditetapkan ataupun untuk dibayar bila dituntut, sama ada dengan mendapat faedah atau tidak.
- iv. **Syarikat Awam Berhad** juga merupakan sebuah perbadanan swasta yang ditubuhkan, dengan tanggungan berhad, oleh sekurang-kurangnya dua orang untuk menjalankan perniagaan dengan tujuan

mencari keuntungan. Saham syarikat awam berhad ini dipegang secara terbuka dan bagi sesebuah syarikat yang disenaraikan di Bursa Saham, sahamnya boleh bertukar milik secara bebas. Syarikat tersebut dianggap sebagai entiti yang sah dan ditubuhkan mengikut Memorandum dan Artikel Persatuan.

- v. **Koperasi** merujuk kepada sesebuah persatuan sukarela yang bilangan ahlinya tidak terhad dan didaftarkan di bawah Akta Koperasi 1993. Kumpulan wang yang ada ialah milik bersama untuk memenuhi keperluan ahli-ahlinya.
- vi. **Perbadanan awam** merujuk kepada sebuah perbadanan yang ditubuhkan di bawah Akta Parlimen atau Dewan Perundangan Negeri.
- vii. **Pertubuhan persendirian tidak mencari keuntungan** merujuk kepada syarikat tanpa saham yang ditubuhkan dengan tanggungan berhad. Kebanyakan syarikat ini terdiri daripada pertubuhan kebajikan, keagamaan, pendidikan, kesihatan, kebudayaan, rekreasi dan pertubuhan lain yang memberikan perkhidmatan sosial dan kemasyarakatan kepada isi rumah. Perkhidmatan diberikan secara percuma atau pada harga yang tidak melebihi kos perkhidmatan. Sebarang keuntungan yang diperoleh dilabur semula ke dalam pertubuhan berkenaan.
- viii. **Lain-Lain** merujuk kepada semua pertubuhan lain yang tidak termasuk dalam mana-mana kategori yang tersebut di atas.

#### **Hak milik**

Hak milik sesebuah estet dikelaskan mengikut taraf pemastautin pemilik/pemilik-pemilik modal berbayar terbesar (melebihi 50%) dan bukannya mengikut taraf kewarganegaraan mereka. Dalam kes di mana setiap pihak (Pemastautin Malaysia dan bukan pemastautin Malaysia) memegang bilangan saham yang sama dalam perniagaan berkenaan maka pertubuhan tersebut dikelaskan di bawah ‘Hak milik bersama’.

	Pemastautin Malaysia ditakrifkan sebagai orang, syarikat atau institusi yang tinggal atau terletak di dalam Malaysia tidak kurang daripada 1 tahun. Bukan pemastautin Malaysia pula ialah orang, syarikat atau institusi yang tinggal atau terletak di luar Malaysia kurang daripada 1 tahun.
<b>Keluasan bertanam</b>	Keluasan bertanam dengan getah (matang dan/atau belum matang) dan tidak terbiar selama-lamanya.
<b>Keluasan matang</b>	Keluasan getah yang telah ditoreh atau yang dianggap sebagai sudah boleh ditoreh oleh pemilik estet atau individu yang mengemukakan soal selidik.
<b>Keluasan belum matang</b>	Keluasan getah yang dianggap belum boleh ditoreh oleh pemilik estet atau individu yang mengemukakan soal selidik.
<b>Keluasan tanam baru</b>	Ia merujuk kepada getah yang ditanam di atas tanah yang dahulunya tidak ditanam dengan getah.
<b>Keluasan tanam semula</b>	Ia merujuk kepada getah yang ditanam semula di atas tanah yang dahulunya ditanam dengan getah.
<b>Purata keluasan ditoreh</b>	Ia adalah purata keluasan di bawah getah matang yang telah ditoreh termasuk kawasan yang "direhatkan" di bawah sistem giliran torehan.
<b>Pengeluaran</b>	Pengeluaran getah asli merujuk kepada kandungan getah kering (KGK) bagi susu getah cair, getah keping dan skrap (getah buku dan getah kulit) yang dihasilkan oleh estet dan pekebun kecil.
<b>Hasil</b>	Hasil diperoleh dengan membahagikan jumlah pengeluaran untuk tahun berkenaan dengan purata luas hektar yang ditoreh sepanjang tahun.
<b>Import dan eksport</b>	Data import dan eksport dikumpul oleh Jabatan daripada borang pengikrarann import dan eksport yang diperoleh daripada Jabatan Kastam Diraja Malaysia dan Lembaga-Lembaga Zon Bebas. Angka

perdagangan luar negeri Malaysia tidak termasuk perdagangan antara kawasan iaitu antara Semenanjung Malaysia, Sabah dan Sarawak.

- i. **Import** adalah sesuatu barang yang dibawa masuk ke dalam negara, sama ada secara terus atau disimpan di gudang-gudang yang dikawal. Barang-barang tersebut adalah sama ada untuk kegunaan sendiri, diproses, digunakan dalam perkilangan ataupun untuk dieksport semula ke negara lain. Pengelasan import ini diistilahkan juga sebagai ‘import umum’. Di dalam laporan ini, import dikelaskan mengikut negara asal barang tersebut, iaitu negara di mana barang berkenaan terakhir dibuat sebelum ianya diimportkan ke dalam kawasan pendaftaran.
- ii. **Eksport** adalah sesuatu barang (keluaran atau buatan tempatan atau diimport untuk dieksport semula) yang dibawa keluar dari negara. Di dalam laporan ini, eksport dikelaskan mengikut negara dituju, iaitu negara di mana barang-barang berkenaan dijangka akan digunakan, sejauh mana ia boleh ditentukan pada masa ianya dieksport. Bagi barang yang dihantar berdasarkan *"Optional bill of lading"*, pelabuhan pertama yang diikrarkan dianggap sebagai negara yang dituju. Sekiranya maklumat negara yang dituju bagi barang-barang yang dieksport melalui Singapura tidak diketahui/diperoleh, eksport sedemikian diambilkira sebagai eksport ke Singapura, iaitu di bawah kategori yang sama seperti barang-barang yang digunakan di Singapura. Eksport termasuk eksport semula. Pengelasan eksport ini diistilahkan juga sebagai ‘eksport umum’.

<b>Penggunaan domestik</b>	Ia merujuk kepada penggunaan domestik getah asli seperti susu getah pekat, Getah Mutu Malaysia (G.M.M.), Getah Asap Berbunga (G.A.B.) dan sebagainya oleh pertubuhan pembuatan di Malaysia untuk mengeluarkan barangan seperti tayar dan tiub, kasut getah, sarung tangan getah, benang getah, getah campuran dan lain-lain.

<b>Stok</b>	Ia adalah stok getah yang dimiliki oleh sesebuah pertubuhan tidak kira di mana stok tersebut ditempatkan iaitu sama ada di dalam atau di luar kilang. Ia termasuk stok getah yang belum/sedang/telah diproses.
<b>Harga</b>	Data harga getah diperoleh daripada sumber-sumber berikut:- <ul style="list-style-type: none"> <li>i. Lembaga Getah Malaysia (LGM) Purata harga pembeli waktu tengahari untuk getah "F.O.B." di Kuala Lumpur.</li> <li>ii. Kumpulan Kajian Getah Antarabangsa (IRSG) Harga pembeli untuk London dan harga yang diminta oleh penjual bagi penghantaran sepanjang bulan semasa untuk New York.</li> </ul>
<b>Harga purata</b>	Harga purata dikira dengan mencampurkan harga getah harian dan membahagikan jumlah harga tersebut dengan bilangan hari berniaga dalam sesuatu bulan/tahun.
<b>Perangkaan dunia</b>	Selain daripada data getah Malaysia, data yang dipersembahkan juga meliputi <b>(getah asli dan tiruan)</b> perangkaan getah dunia yang diperoleh dari " <i>Rubber Statistical Bulletin</i> " yang diterbitkan oleh <i>International Rubber Study Group (IRSG)</i> .
<b>Gunna tenaga</b>	Jumlah orang yang diambil bekerja dalam sesebuah estet getah ditakrifkan sebagai jumlah bilangan orang yang diambil bekerja dalam bulan Disember atau dalam tempoh pembayaran gaji terakhir bagi satu-satu tahun rujukan. Bilangan orang yang bekerja termasuk semua pemilik yang bekerja dan rakan niaga yang aktif, pekerja keluarga tidak bergaji dan pekerja bergaji seperti yang ditakrifkan di para berikut. Turut termasuk adalah pekerja sambilan yang terdapat di dalam daftar gaji dan pekerja yang mogok, berpiket dan bercuti jangka pendek (cuti sakit, cuti rehat atau cuti kecemasan). Mereka yang tidak diambilkira ialah mereka yang dalam cuti berpanjangan.

- i. **Pemilik yang bekerja dan rakan niaga yang aktif** merujuk kepada semua pemilik perseorangan dan rakan niaga, sambilan atau sepenuh masa, yang bekerja dengan aktif dalam pertubuhan tersebut. Justeru itu, ia tidak termasuk rakan niaga yang tidak aktif.
- ii. **Pekerja keluarga tidak bergaji** merujuk kepada semua ahli isi rumah pemilik pertubuhan yang melaksanakan kerja tertentu (sepenuh masa atau sambilan) dan bekerja sekurang-kurangnya satu pertiga daripada waktu bekerja biasa tanpa mendapat bayaran secara tetap, sama ada dalam bentuk wang tunai atau mata benda bagi kerja yang dilakukan. Biasanya pekerja berkenaan mendapat makanan, tempat tinggal dan bantuan lain sebagai sebahagian daripada ahli isi rumah pemilik tersebut dan terus menikmatinya sama ada ia bekerja atau tidak di estet berkenaan.
- iii. **Pekerja bergaji sepenuh masa** ditakrifkan sebagai semua pekerja bergaji yang bekerja sekurang-kurangnya 6 jam sehari dan sekurang-kurangnya 20 hari sebulan.
- iv. **Pekerja bergaji sambilan** ditakrifkan sebagai semua pekerja bergaji yang bekerja kurang daripada 6 jam sehari dan/atau kurang daripada 20 hari sebulan.

**Gaji & upah yang dibayar**

Ia merujuk kepada emolumen kasar yang dibayar kepada pekerja sepanjang tahun rujukan termasuk gaji, upah, bonus, komisen, bayaran lebih masa, bayaran pampasan dan elaun lain sebelum ditolak sumbangan pekerja kepada Kumpulan Wang Simpanan Pekerja (KWSP), Pertubuhan Keselamatan Sosial (PERKESO) atau sumbangan lain. Tidak termasuk elaun kepada pemilik yang bekerja, rakan niaga yang aktif dan pekerja keluarga tidak bergaji.

**Harta**

Harta meliputi semua barang, baru atau terpakai yang mempunyai hayat produktif lebih daripada setahun (seperti tanah, bangunan, jentera dan alat kelengkapan, termasuk kelengkapan pengangkutan). Nilai yang dilaporkan adalah nilai seperti pada

penghujung tahun dan ia mengikut buku akaun unit yang melapor. Ia termasuk perolehan baru sepanjang tahun berkenaan tetapi tidak termasuk harta yang dilupuskan pada tahun tersebut. Ianya adalah nilai bersih setelah ditolak susut nilai.

**Pembundaran** Jumlah bagi komponen-komponen mungkin berbeza dengan jumlah besar di dalam jadual-jadual penerbitan disebabkan oleh pembundaran angka.

***Introduction***

*This report provides information on rubber estates canvassed from the Annual Census of Rubber Estates for reference year 2010. It also contains secondary data obtained from sources such as the, Malaysian Rubber Board (MRB), Rubber Industry Smallholders Development Authority (RISDA), Federal Land Development Authority (FELDA), Federal Land Consolidation and Rehabilitation Authority (FELCRA) and International agencies such as the International Rubber Study Group (IRSG).*

***Objective***

*The main objective of this report is to provide statistics on rubber with regards to hectareage planted, production, yield, employment, salaries & wages, imports and exports of rubber as well as detailed statistics on rubber estates. These statistics will assist the government in development planning, formulation of policies as well as monitor the development of rubber based industries. The data can also be used by the private sector and individuals for research and economic analysis.*

***Legal authority***

*The census was conducted under the Statistics Act 1965 (Revised 1989). Under the Act, the contents of individual returns will be kept confidential. In conformity with the requirements of this Act, only aggregated figures are published.*

***Scope and coverage***

*The census covered all rubber estates in Malaysia. The main sources of the census frame were the Companies Commission of Malaysia (CCM) and the Malaysian Rubber Board (MRB). For Sabah and Sarawak, additional information was obtained from District Offices and District Agriculture Offices.*

***Concepts and definitions***

*Concepts and definitions used are based on the recommendations of the Statistical Office of the United Nations, thereby facilitating international comparability of data.*

*i. A rubber estate is defined as:*

*a. all areas, contiguous or non-contiguous, aggregating not less*

- than 40.47 hectares (100 acres), planted with rubber or on which the planting of rubber is permitted and is under a single legal ownership; or*
- b. *any area planted with rubber in a coconut, cocoa or oil palm estate.*

ii. *A rubber smallholding is defined as all areas, contiguous or non-contiguous, aggregating less than 40.47 hectares (100 acres), planted with rubber or on which the planting of rubber is permitted and is under a single legal ownership. Smallholdings can be organized or unorganized. Organized smallholdings include those under various government schemes such as follows :-*

- a. *Federal Land Development Authority (FELDA);*
- b. *Rubber Industry Smallholders Development Authority (RISDA);*
- c. *Federal Land Consolidation and Rehabilitation Authority (FELCRA);*
- d. *Other Federal Government land schemes; and*
- e. *State Government land schemes.*

**Reference year**

*The reference period for the survey is the calendar year 2009. However, for establishments whose accounting year differed by less than six months from the calendar year, the accounting or financial figures were accepted as representative of the data for the calendar year.*

**Methodology**

*The census was primarily conducted by mail inquiry using a questionnaire. Respondents were given one month to complete and return the questionnaire to the Department, after which field enumeration was undertaken to obtain completed reports from the non-response establishments.*

**Legal status**

*The legal status of an establishment has been defined as follows:*

- i. *Individual proprietorship refers to a business, owned and operated by one person for his own profit. The owner has the exclusive right to control the operations of the establishment.*

- ii. **Partnership** refers to a group of individuals who agree to contract and to carry on a business with the objective of making a profit. The business is managed by all or any one acting for all parties. A trading partnership must comprise at least two members and should not exceed a maximum of twenty members.
- iii. **Private Limited Company** is a private corporation established to undertake a business with the objective of making a profit. The shares are closely held by shareholders of the corporation who has control over its operation. It is registered with limited liability. A private limited company has its Memorandum and Articles of Association, which among others:
- a. restricts the right to transfer its shares;
  - b. limits the number of its shareholders between two to fifty (not including employees of the company and past employees who are currently members);
  - c. prohibits any invitation to the public to subscribe for any share or debenture of the company; and
  - d. prohibits any invitation to the public to deposit money with the company for fixed periods or payable at call with or without interest.
- iv. **Public Limited Company** is also a private corporation established, with limited liability, by a minimum of two persons to operate the business with the objective of making a profit. The shares in a public limited company are openly held and in the case of a company listed on the Stock Exchange, the shares are freely transferable. The company is regarded as a legal entity and is constituted by the Memorandum and Articles of Association.
- v. **Co-operative** refers to a voluntary association with an unrestricted number of members and registered under the Co-operatives Act 1993. Funds are collectively owned to meet the needs of the members.

vi. **Public corporation** refers to a corporation set up under a special Act of Parliament or by the State Legislature.

vii. **Private non-profit making organisation** is a non-stock company set up with limited liability. It comprises mainly welfare, religious, educational, health, cultural, recreational and other organisations providing social and community services to households. These services are provided free of charge or at prices, which do not necessarily or fully cover the cost of providing such services. Any profit made is re-invested in the organization.

viii. **Others** refer to all other establishments, which do not fall under any of the categories mentioned above.

**Ownership** The ownership of an estate is classified by the residential status of the owner(s) of the majority (more than 50%) of the paid-up capital and not by their citizenship status. In instances where each party (Malaysian residents and non-Malaysian residents) held equal shares in the business, the establishments were classified under 'Joint ownership'.

A Malaysian resident is defined as a person, a company or an institution that lives or is located in Malaysia for a period not less than a year. A non-Malaysian resident is a person, a company or an institution that lives or is located outside Malaysia for a period less than a year.

**Planted area** The area planted with rubber (mature and/or immature) and which has not been abandoned permanently.

**Matured area** The area of rubber which is either being tapped or which is considered tappable by the estate owner or individual submitting the return.

**Immatured area** The rubber area which is considered by the estate owner or individual submitting the return to be not yet tappable.

<b>Newly planted area</b>	<i>This refers to rubber planted on land previously not planted with rubber.</i>
<b>Replanted area</b>	<i>This refers to rubber replanted on land previously planted with rubber.</i>
<b>Average tapped area</b>	<i>This is the average area under mature rubber that has been tapped including areas "rested" under rotational systems.</i>
<b>Production</b>	<i>Production of natural rubber refers to the dry rubber content (DRC) of field latex, rubber sheets and scrap (lump and bark) produced by estates and smallholders.</i>
<b>Yield</b>	<i>The yield is derived by dividing the total production for the year by the average hectareage tapped during the year.</i>
<b>Imports and exports</b>	<p><i>The data on imports and exports are compiled by the Department of Statistics from declaration forms sourced from the Malaysian Royal Customs Department and Free Zone Authorities. External trade data for Malaysia do not include inter-regional trade between Peninsular Malaysia, Sabah dan Sarawak.</i></p> <ul style="list-style-type: none"> <li>i. <i>Imports are goods brought into the country either directly or into bonded warehouses, whether or not such goods are for consumption, to be processed, used in manufacturing or for subsequent re-export to other countries. This categorisation of imports is also termed as 'general imports'. In this report, imports are classified according to the country of origin of the goods, that is, the country where the goods are given the final form before they are imported into the registration area.</i></li>   <li>ii. <i>Exports are goods (locally produced or manufactured or imported for subsequent re-exports) taken out of the country. In this report, exports are classified according to the country of destination, that is, the country where it is expected that the goods will be consumed insofar as this can be ascertained at the time of export. In the case of goods shipped on an "Optional bill of lading", the country of</i></li> </ul>

*destination refers to that of the first port declared. If the information regarding the country of destination of goods exported via Singapore is not known/available, such exports are included under the value of exports to Singapore, that is, under the same category as goods consumed in Singapore. Exports include re-exports. This categorisation of exports is also termed as 'general exports'.*

<b>Domestic consumption</b>	<i>This refers to the usage of natural rubber such as latex concentrate, Standard Malaysian Rubber (S.M.R.), Ribbed Smoked Sheet (R.S.S.), etc. by manufacturing establishments in Malaysia to produce products such as tyres and tubes, rubber footwear, rubber gloves, rubber threads and others.</i>
<b>Stocks</b>	<i>This refers to stocks of rubber owned by establishments regardless where it is located i.e. inside or outside the factory. They include stocks of unprocessed/in process/ processed rubber.</i>
<b>Prices</b>	<i>Data on prices are obtained from the following sources:</i> <ol style="list-style-type: none"><li>i. <i>Malaysian Rubber Board (MRB)</i> <i>Average buyers' mid-day prices for rubber "F.O.B." in Kuala Lumpur.</i></li><li>ii. <i>International Rubber Study Group (IRSG)</i> <i>Buyers' prices for London and sellers' asking prices for delivery during the current month for New York.</i></li></ol>
<b>Average price</b>	<i>The average price is derived by adding the daily rubber prices and dividing the total prices by number of trading days during a reference month/year.</i>
<b>World statistics (natural and synthetic rubber)</b>	<i>Other than data for Malaysia, the data presented in this report also include rubber statistics of the world which was obtained from the "Rubber Statistical Bulletin" published by the International Rubber Study Group (IRSG).</i>

**Employment** *Employment in an establishment is defined as the total number of persons employed during December or the last pay period of the reference year. The number of persons engaged include all working proprietors and active business partners, unpaid family workers and employees as defined in paragraphs i. to iv. Included are part-time workers in the payroll and persons on strike, picket and short-term leave (sick, vacation or emergency leave) excluding workers on indefinite leave.*

- i. **Working proprietors and active business partners** refer to all individual proprietors and partners, part-time or full-time, who are actively engaged in the work of the establishment. It therefore excludes silent and inactive partners.
- ii. **Unpaid family workers** is defined as all persons (full-time or part-time) of the household of any of the owners of the establishment who perform a specified job and work for a minimum of one third of the normal working time of the establishment, but do not receive regular payment either in cash or in kind for the work done. Such workers generally receive food, shelter and other support as part of the household of an owner but these provisions would continue whether they worked in the establishment or not.
- iii. **Full-time employees** is defined as all paid workers who work for at least 6 hours a day and for at least 20 days a month.
- iv. **Part-time employees** include all paid workers who work for less than 6 hours a day and/or less than 20 days a month.

**Salaries & wages paid** *This refers to gross emoluments paid to employees during the reference year, inclusive of salaries, wages, bonuses, commission, overtime pay, dismissal pay and other allowances before deduction of employees' contribution to Employees Provident Fund (EPF) Social Security Schemes (SOCSO) or any other deduction. Allowances to working proprietors, working partners and unpaid family workers are not included.*

**Assets** *Assets cover all goods, new or used, that have a normal economic life of more than one year (e.g. land, building, machinery and equipment, including transport equipment). The value reported is as at the end of the year and is according to the books of accounts of the reporting unit. It includes additions during the year and excludes assets disposed off during the year. It is net of depreciation.*

**Rounding** *The sum of the components may not add up to the totals in the tables presented in this publication due to rounding.*
