I. Background of the Forum

The National Practitioner Forum, in Phnom Penh, on 7-8 December 2010 was hosted by World Vision Cambodia (WVC) and the United Nations Inter-Agency Project on Human Trafficking (UNIAP). It was intended to:

- 1- Create a national dialogue and network to better understand and respond to the needs of victims of trafficking for their effective reintegration into society and to share experiences and lessons learned among relevant stakeholders;
- 2- Review reintegration services provided to victims of trafficking upon voluntary return by government agencies, IOs, NGOs and community groups;
- 3- Identify and prioritize practical challenges, obstacles, gaps and recommendation to effective voluntary return and (re)integration;
- 4- Review application of national minimum standards & guidelines in (re)integration work and identify strengths as well as areas for improvement;
- 5- Take into account relevant government policies, procedures, and practices, and their effectiveness and impact on (re)integration of victims of trafficking

Moreover, the conduct of the forum responded to the pledge made by COMMIT Taskforce at the Senior Ministerial Meeting 7 in Myanmar 2010 on good practices in reintegration assistance (COMMIT PPC-5) compared against the COMMIT SPA II Joint Targets and Timelines.

The Forum attracted various practitioners of both governmental and non-governmental actors who directly and indirectly provide reintegration services for (potential) victims of trafficking and labor exploitation. In total, there were 159 participants who represent Ministries of Interior, of Social Affairs, of Labor, of Women's Affairs and of National Committee to Suppress Trafficking and of Cambodia COMMIT Task Force, Embassies of Thailand and Vietnam, international organizations/UN agencies and donors and various local NGOs who are currently working in reintegration sector (annex 2: list of participants).

A regional report combining the outcomes of the national forums in the six countries of the Greater Mekong Sub-region (GMS) will be prepared for submission to the Cambodian Government (through the Ministry of Social Affairs, Veterans and Youth Rehabilitation), COMMIT Task Force members at SOM-8 and IMM in mid 2011. Recommendations from the report will be put forth for inclusion in the planning and implementation of COMMIT SPA-3.

II. Opening remarks

Representatives from World Vision Cambodia and the United Nations Inter-Agency Project on Human Trafficking welcomed the participants in the forum. They stated that reintegration of victims of trafficking is a great challenge no matter where it is implemented around globe.

H.E. San Arun, Secretary of State of the Ministry of Women's Affairs and the COMMIT Taskforce Chair thanked World Vision Cambodia, UNIAP and other partners for organizing the practitioner forum in order to share experiences and gaps/issues and collect recommendations to improve reintegration work in the future. Her Excellency stated that Royal Government of Cambodia, particularly the COMMIT taskforce, has been strongly committed to working with different stakeholders to combat trafficking.

H.E. Sar Kheng, Deputy Prime Minister, Minister of Interior and the Head of National Committee to Lead the Suppression of Human Trafficking, Smuggling, Labor Exploitation and Sexual Exploitation in Women and Children (S.T.S.L.S) appreciated the initiative and the commitment to fight against human trafficking and emphasized that reintegration was critical to assist victims of trafficking and he encouraged the stakeholders, including civil society private sectors and ministries, to provide services to respond to the needs of victims human trafficking cooperatively.



III. Presentations¹

Repatriation and Reintegration of Male victims of Trafficking By Ms. Chan Kanha, IOM

In cooperation with the Ministry of Foreign Affairs and International Cooperation (MoFAIC) an official procedural mechanism for the return was established to allow for an efficient and safe return of Cambodian trafficking victims from Malaysia.

In the past five years cases of trafficking to Malaysia involved both men and women and for a range of exploitative purposes, especially men for fishing industry.

The Cambodian Embassy in Malaysia identifies the victim using the International Organization for Migration (IOM) screening form. When case(s) are identified, the embassy notifies MoFAIC of the victims and requests assistance from the IOM. After having the approval from its Head Quarter (HQ), IOM works with the Ministry of Social Affairs, Veterans and Youth Rehabilitation (MoSVY) to repatriate the victims with protection standards to the rights of victims of human trafficking. Within this protection stage, returnees receive medical checkups, family tracing and reintegration with their family. So far, IOM has assisted MoSVY to reintegrate and support 47 male victims of trafficking.

Experiences on Reintegration of Victims of Trafficking for Sexual Exploitation and Labor Exploitation By Mr. Ray Sano, World Vision Cambodia

Since late 1997, World Vision Cambodia (WVC) has been implementing reintegration services to assist victims of human trafficking for sexual abuse and labor exploitations with collaboration and support from various partners including government ministries, embassies, NGOs. The support for the victims including immediate assistance to cover basic needs, counseling and medical assistance, sheltering for both short and long term, vocational training, family tracing and assessment, capital for income generating activity, legal supports in collaboration with NGO partners and following up with the family of the returnees.

Through implementation of the reintegration services, WVC has had some good practices and challenges. Good practices include the involvement of family as soon as possible, involvement and support of local authority, and government staff especially those of social affairs, women affairs, police, and education, etc. These are the people who will be with the community even after NGO had left. Family assessment and relevant support e.g. housing repair, and material and capital for income generating activity are crucial for longterm and sustainable reintegration. Medical check-up and health care, counseling, vocational and life skill, and regular follow-up are very critical elements for successful reintegration. Challenges and difficulties are remoteness and scattering geographical locations of clients' home villages, high cost of reintegration, limited cooperation from victims in the legal process due to time consuming and their fear of implication and involvement of family members in trafficking.

Overview on government's reintegration services and existing guidelines, standards, and policies.

The Ministry of Social Affairs, Veterans and Youth Rehabilitation (MoSVY) had established the Anti-Trafficking in persons and Reintegration Office (ATRO) under the supervision of Department of Social Welfare and Poipet Transit Center to accept and reintegrate victims of human trafficking from Thailand and Vietnam to return and live with their families and communities.

MoSVY has experience in repatriation of victims to Vietnam. There were nine different steps in the process.

- Rescue and Recovery: this is done by the Anti-Human Trafficking and Juvenile Protection Department (AHTJPD) with collaboration from officials from Social Affairs at the municipal and provincial level for victim identification and service referral.
- Volunteer repatriation: Vietnamese victims who wish to return home, will be interviewed in a particular form in three languages, Khmer Vietnamese and English, with consent;
- MoVSY, Directorate of Technical Department, coordinates with the Vietnamese embassy in Cambodia for official repatriation;
- Vietnamese authority at home country opens up family tracing and assessment;
- After feedback from the Public Security, the Vietnamese embassy informs ATRO and they are ready to issue a border pass to the victims and MoSVY will carry on next steps in the procedures;
- Repatriation will be set on before Vietnamese embassy, MoSVY, IoM and Shelter;
- MoSVY submits a request to MoI, the National Police Commissariat, for an Exit Pass, and an immigration police officer involvement in escorting;
- Repatriation takes place;
- Official reception from both countries' respective authority, shelter service providers, IOM at border check point Bavet-Mokbai.

IV. Group Discussion

On the first day of the Forum, participants were divided into 6 groups to discuss reintegration service availability, working geographical areas, referral system, challenges, gaps and recommendations to improve the current situation. The six groups are 1) immediate support and emergency package; 2) Medical and psychological support; 3) Shelter and interim care; 4) Education, vocational training and employment; 5) Legal aid; and 6) Community acceptance and integration. There were 41 organizations and 2 government ministries who directly joined the discussions and presented the following:

A. Available Services:

- Repatriation and return facilitation
- On-arrival support/reception
- Temporary accommodation
- Basic need package
- Transportation fee for traveling back home
- General medical care
- Clinical treatment
- Mental health care and psychological therapy
- Psycho-social counseling
- Transportation fee to access health services
- Shelters/centers
- Interim care (including food, supplies, health check-up, life skills...)
- Formal education and available support/scholarship
- Informal education and available support/scholarship
- Job placement
- Start-up capital and logistics assistance
- Vocational training
- Legal counseling, investigation and representation
- Family tracing
- Post-reintegration follow-up and monitoring
- Referral hotline and coordination service
- Self-help group service

Even not all the above services cover all capital/provinces of Cambodia, some organizations tried to extend their available services to 24 capital/provinces.


Service mapping of both governmental and non-governmental organizations who reported to the Forum

B. Gaps and Recommendations from Groups Discussions:

Group 1: Immediate Support and Emergency Package

Stakeholders found out gaps / challenges in implementation as follows:

- There is lack of cooperation and coordination with partners in the country and with • neighboring countries.
- The family tracing is not always successful due to incorrect address and remoteness;
- There is a lack of shelters for victims, particularly male victims •
- The resource and finance to implement the activities are limited;
- Victim identification is still a challenge. •

Group 2: Medical and Psychological Support

At the end of group discussion, a few main challenges were revealed:'

- The treatment of trauma victim only at certain places such as in Takmao Hospital, Kandal Province, and Russia hospital
- There is a lack of psychosocial specialists.
- No psychosocial technical model for working with victims of sexual abuse
- Victims wait for a long time to receive medical care and service

Group 3: Shelter and Interim Care Services

Hagar International, Pteah Toek Daung, Poipet Transit Center, Destiny Rescue, World Hope International, Health Care for Children, White Lotus, World Vision Cambodia and ARM International provided shelter and interim care services to the victim in short and long term. They face some challenges:

- Security at a shelters is a great concern;
- There are no shelters with specialized expertise in hosting handicapped women and children;
- It is difficult to find children's original families as they do not have birth certificates.
- Financial support is required for running a shelter as the cost is high

Group 4: Education, Vocational Training and Employment

The stakeholders provided education services both formal and informal education and vocational training but gaps remain:

- Partnership with private sector is very limited
- No market assessment has been conducted.
- The training courses do not respond to the labor market in the areas where returnees are reintegrated to.
- Some vocational training courses require victims to have some levels of literacy first before they are allowed to get the skills.
- Interests of loans from microfinance institutions are too high (5% and above) for the vulnerable families to afford.

Group 5 Legal Aid Support

Several NGOs provided legal supports to the victim from the consultation to representation at the court. Nevertheless, these institutions faced challenges such as:

- Budget and resources including human resources like lawyers particularly on crossborder cases are far from sufficient,
- Cooperation from the victims and families in the legal process is limited as they are fearful of implication
- No law on evidence makes it difficult for legal support work.

Group 6: Community Acceptance and Integration

Below are the gaps stated by the group:

- The turnover rate of official both from government and civil society is quite high; therefore, communicating took more time to find the right person.
- It is difficult to locate victims as they often move from place to place.

• Life cycle of most of the project for victim reintegration is short, which is a constraint for successful reintegration.

Note: Though most available services are provided to only women and children, several NGOs such as The Future (012 310 582), Hagar, Women Association for Community Development (017 734 114), World Vision Cambodia and Cambodia Red Cross ascertained that their projects also covered male victims of trafficking.

On the second day of the Forum, participants were divided into 4 groups to discuss capacity building and ethics, practitioner system and collaboration and policy framework and resources and sustainability by focusing on available things, gaps and recommendations.

Following the discussion, most participants expressed that more and better capacity building is still needed on various topics including TIP law and victim identification, practical case management system, proposal review and best technique to mobilize resources and systematic approach to reintegration process. Other organizations found that there is still a lack of sharing external evaluation and research results to outside agencies. Some shelters and NGOs seek more cooperation and legal framework (for example guardianship) from authority and strongly suggested that there should be a government policy on taking over from NGO partners after the reintegration. Furthermore, victims and their families sometimes make it difficult for service providers to implement NGOs' projects. In the name of government, MoSVY officials insisted that all NGOs should follow the Circular on Ministerial Guidelines so that the national minimum standards will be

fully applied nationwide. A representative of Anti-Human Trafficking and Juvenile Protection Police found that Cambodia starts developing the standard operating procedure, particularly with Vietnam, so that victim identification and rescue will be conducted effectively.

After plenary reporting session, participants drew attention on issues faced. The most common and highlighted were:

- There was a case of a child born in Cambodia from alien parents whose status has been in trouble in seeking citizenship document for proceeding formal education as required. The service provider was suggested that it would be better to refer this case to the Ministry of Interior at the Department of Local Administration for recommendation. Moreover, the forum was told to refer to the law on immigration and a sub-decree on the issuance of Khmer ID card dated 1996 in which describes how the Cambodian nationality being granted. Basically, the child is born from alien parents who must be born and live legally in Cambodia.
- Another important issue emphasized was lawful operating of shelters, The Ministry
 of Social Affairs Veterans and Youth Rehabilitation encouraged the shelter service
 providers to work out with MoSVY for a Memorandum of Understanding (MoU). It
 would be very important tool to mutually support the implementation. Recently,
 there were some complaints lodged against shelter in unlawful detention or
 confinement. Brigadier General from the Department of Anti-Human Trafficking and
 Juvenile Protection (AHTJP) of the Ministry of Interior (MoI) informed that police did

not have shelter to host victims, so cases had been referred to NGO shelters. To make it safer, NGO shelters should have a regular basis report submit to the police so that the unit would be able to inform prosecutor on the case before something bad happened. It was also good news to learn that Ministry of Justice drafted a guardianship law to ease condition but we did not know that latest status and when it would finish.

- One significant concern from the forum was both government and NGO agents, throughout discussion, shared about limited cooperation. The question was how to tackle this challenge. According to the official, there were two reasons that drive to non-smooth cooperation. First of all, turnover rate in the police unit was quite high, consequently, the communication has lost midway at the same time that person transferred to other section. Secondly, finding a key person would solve this limitation. Hence, development partners had to understand and find out the right person to work with, otherwise it took lots of time to proceed. V. Gaps and Recommendations

Lim Tith, UNIAP National Project Coordinator, summed up the discussion in the forum and came up, inter alia, with the following recommendations:

- 1- Capacity building needed to be carried out in all forms to equip to stakeholders on:
 - Policies
 - Standard Operating Procedure
 - Fund raising and budgeting
 - Ethical standards on caring victim of trafficking at shelters.
- 2- MoSVY and NGOs which run shelter should develop and formalize any regulations to become a lawful shelter so that NGOs would have rightful custodianship to protect victims;
- 3- Coordination between stakeholders was limited due to time and interest therefore, information sharing was absent;
- 4- There is no monitoring and evaluation mechanism on reintegration in Cambodia yet;
- 5- The protection support was merely to the victims. But the whole family were in need so the vulnerability and re-victimization were at large;

VI. Closing

In his closing remarks, **His Excellency Dr. Ith Samheng** the Minister of Social Affairs, Veterans and Youth Rehabilitation (MOSVY), Vice Chair of National Committee to Lead the Suppression of Human Trafficking, Smuggling, Labor Exploitation and Sexual Exploitation in Women and Children (S.T.S.L.S) thanked the participants of the forum for their time and efforts. He said the experience and lessons learned from the forum play an important role in strengthening the existing mechanism for implementing plan of action to have successful reintegration. He also said that to make this happen, MOSVY wished to highlight some key points as follows:

- MOSVY will continue the cooperation with stakeholders to implement the Policy and Minimum Standards for Protection of the Rights of Victim of Human Trafficking.
- MOSVY requests that authorities at all levels and the communities should collaborate in assisting victims of human trafficking.
- The existing mechanisms should be strengthened and used as channels between ministries and local levels to offer protection and support for the victims of human trafficking.
- Victims and their needs should be clearly identified so as to effective responses.
- Policies and regulations should be created to serve the best interests of the victims and reduce/prevent vulnerability of the people in the short and long terms
- Human resources should be developed with attachment of the importance of good will and wisdom
- Resources such as equipment, materials and budget are required to have functional administration and achieve mission.

In addition, H.E. Dr. Ith Samheng took time to respond to some gaps and challenges which were raised by the group discussion in the Forum as the following:

- Some gaps in human resources development: This is an important issue. To
 provide good quality services for victims, human resources with wisdom,
 responsibility and skills are needed. MOSVY is in the process of creating a National
 Institute of Social Work under MOSVY in order to train MOSVY officials and other
 relevant stakeholders in the government, NGOs and private sector.
- Limited financial resources: MOSVY has faced the challenge. NGOs have contributed to mitigating this challenge. To be able to have some fund for reintegration work, MOSVY must comply with the regulations and policies.
- **Referral to shelters**: MOSVY has only Poipet Transit Center and has planned to have a shelter in Svay Rieng to receive the victims and vulnerable people from Bavet border crossing. MOSVY is grateful for NGOs who have admitted victims to their shelters. However, regulations, particularly on custodianship for shelters, are to be established and standard of services should be set.
- Limited knowledge on ethics for victims: It needs to be further strengthened and disseminated.
- Promotion of implementation of the National Policy for Protection of the Rights of Victim of Human Trafficking: Cambodia is the first country to have this kind of policy. All stakeholders should make more efforts to disseminate and implement it.
- Limited cooperation between government institutions and NGOs: MOSVY alone cannot carry out counter trafficking activities, particularly reintegration. This requires coordination to be able to successfully and effectively do the tasks.
- No monitoring and evaluation system: it is needed to understand whether a project has been successfully executed or not and to collect lessons learned for future project activities.

 - After finishing the discussion, participants are nearly ready to get coffee break;
 - However, before going out for break, facilitators shall ask each group's members to stick color pins (each category of service should have one specific color) on a big map (reflecting geographical areas of services provided) displayed in the main room;
 - In the meantime, facilitators shall finish typing and copy text to the main room's laptop so that all groups' results will be shown on the screen during the plenary session (after the coffee break).
