Peaceful and prosperous Myanmar nation with equality, justice and liberation by promoting and protecting the rights of the children today.



In response to Cyclone Nargis in May 2008, the inter-agency Women's Protection Technical Working Group (now known as the Gender Equality Network) was formed specifically to focus on multi-sectoral and cross-cutting issues faced by women in cyclone-affected areas. Specific programming and advocacy efforts included the following:

- Advocating for and contributing to the inclusion of women's needs in Cyclone response assessments and strategic planning documents
- Drafting of the Referral Protocol and Pathway for Gender-Based Violence Cases, and the provision of services
- Adaptation, translation and distribution of key guidance documents including Codes of Conduct, key gender messages, gender guidelines and conduct of research.

The Network now has a broader mandate - both geographically and by taking a more comprehensive approach to gender equality and women's empowerment throughout Myanmar. This is done through: coordination and networking; facilitating capacity development and training; data collection and analysis; and advocacy, communications and research.



Background

To be sustainably developed the mangrove and other critical ecosystems which support the livelihood and food security and disaster risk reduction of local community.





Background

Civil societies, including non-government organizations in Myanmar have been playing important role in social and development sector since pre-independence time. The role of Myanmar NGOs has become more important and crucial when international NGOs came into Myanmar in early 1990s. International NGOs and some UN agencies are in partnering with Myanmar NGOs implementing their programs and projects and this opportunity has given the Myanmar NGOs to become more developed and experienced. Nevertheless, the Myanmar NGOs (MNGOs) used to focus on their own objectives and the purpose of partnership agreements and they had not taken the opportunity to communicated, coordinate and cooperate with other MNGOs with similar scope of work.

In and around 2002, INGOs started meeting among them regularly and they shared information, experience, updated their work and put collaborative effort to resolve their common problems and issues. These events attracted MNGOs and they insisted their partner INGOs to allow them participate in the meetings. By this way, MNGOs started attending the INGO meetings since early 2003.

Another significant event in the history of MNGOs was the first gathering of organizations held in April 2004, at the Inya Lake Hotel. During the single day event the organizations exhibited their activities in the form of photos, doucments and product materials, and an understanding and friendship among MNGOs, have also been built. One of the topics discussed in the meeting was about the Phillippines' NGO network, and many MNGOs got a chance to know the nature of a network for the first time.

Initial attendence of MNGOs at the INGO meeting was high due to their curiosity and enthusiasm. However, when they observed that the issues and agendas of the meeting were not that of their interest, and their participation gradually declined.

Anyway every INGOs and MNGOs agreed to meet among them regularly but not monthly and thus the NGO coordination meeting has been meeting every other month since February 2005 and at the same time both INGOs and MNGOs agreed to meet separately in the following month of the NGO coordination meeting.

Late 2007 and early 2008, MNGOs reviewed the purpose of their meeting and the outcome and expressed the need to put effort to make the meeting more meaningful and fruitful. The initial and consensus agreement was reached early 2008 to start organizing three thematic networks; Health, Environment, and child and women. MNGOs working in Health Sector met about 3 times to indentify the objectives, the basic principles and the functions of the thematic group (Network) before the cyclone Nargis struck Myanmar. These initiatives and efforts were temporarily ceased as most of them were affected and were involved in the rescue and relief work.

All the MNGOs involving in the relief and rescue work of the cyclone, came together weekly and shared information, experience and sought opportunities for new areas of work since middle of May 2008.

With each organisation performing their own activities and the discussions reached by the coordination meeting led to increased awareness among MNGOs about the importance of their own organizations, the necessity of unity and close relationship among them, and the requirement of a body to represent MNGOs in communicating with the government bodies, INGOs and the UN organisations. The MNGOs convinced that only when they were united and well-experienced international donors would acknowledge their integrity and capability, and would make direct contact with MNGOs.

Therefore, formation of Myanmar NGO Network became an unavoidable obligation of leading Myanmar NGOs and which they discussed in a succession of weekly meetings and as the final outcome, the Myanmar NGO Network emerged on 13 August 2008.


Vision/Mission



Background

GIPA Initiative Group (GIPAIG) had been established since March, 2005 starting with 9 initiators from INGO and NGO by the support of International HIV/AIDS Alliance and UNDP. It was changed as Myanmar Positive Group (MPG) (National PLHIV Network) in 2006 to make sure and reduce confusion from the GIPA concept. The main objectives of MPG are building up skills and capacity for PLHIV base on GIPA concept, networking between PLHIV individuals and Self Help Groups, reducing stigma and discrimination among PLHIV and community, representation for PLHIV in Myanmar, advocating for PLHIV rights of access to treatment and quality services and developing more PLHIV Self Help groups. When MPG was established, only 47 Self Help Groups were networked and got more networking with 209 Self Help Groups in 2011. Now, 214 Self Help Groups across from Myanmar are networking with MPG.

MPG becomes a strong network not only for the whole country but also with the Asia Pacific and Global network to collect one collective voice of the needs of PLHIV in Myanmar. The Board and Executive Committee of MPG was set up with 12 representatives from Regionals and

4 representatives from MARPS networks who are elected from Self Help Groups in each region. We had developed Articles of Association of MPG in March, 2011. Two representatives and two alternatives from MPG are representing in Myanmar Country Coordination Mechanism for AIDS, TB and Malaria (MCCM). And then two representatives of MPG are representing in Technical Strategic Group (TSG) for HIV/AIDS Component as permanent members.






