KATA PENGANTAR

Laporan ini membentangkan statistik berkaitan sektor pertanian dan subsektor tanaman berdasarkan Banci Pertubuhan Pertanian Tahunan yang dijalankan pada 2009 bagi tahun rujukan 2008.

Objektif utama laporan ini adalah untuk menerbitkan perangkaan utama berkenaan sektor pertanian serta subsektor tanaman mengikut pertubuhan pertanian. Antara statistik yang dipaparkan adalah nilai output kasar, kos input, guna tenaga dan gaji & upah serta nilai harta yang dimiliki.

Bahagian pertama laporan menggambarkan ringkasan penemuan banci. Jadual perangkaan yang terperinci dipaparkan di dalam bahagian kedua bagi membolehkan pengguna membuat analisis manakala bahagian ketiga memfokuskan kepada aspek teknikal seperti skop dan liputan, definisi serta konsep yang digunakan.

Jabatan ini merakamkan penghargaan kepada semua pihak yang terlibat atas kerjasama yang telah diberikan dalam menjayakan laporan ini. Sebarang ulasan dan cadangan ke arah memperbaiki lagi penerbitan ini pada masa hadapan amatlah dihargai.

This report presents statistics on the agriculture sector and the crops sub-sector based on the Annual Census of Agricultural Establishments conducted in 2009 for reference year 2008.

The main objective of this report is to publish principal statistics pertaining to the agriculture sector as well as crops sub-sector by agricultural establishments. Among the statistics presented are value of gross output, cost of input, employment and salaries & wages as well as value of assets owned.

The first part of the report portrays a summary of the findings of the census. Detailed statistical tables are presented in part two to facilitate analysis by users while the third part focuses on the technical aspects such as scope and coverage, definitions and concepts used.

The Department would like to express appreciation to all those involved for their kind co-operation in making this publication a success. All comments and suggestions towards improving this publication in future would be greatly appreciated.




1. TABURAN PERTUBUHAN

Jumlah bilangan pertubuhan terlibat dalam sektor pertanian yang memberi maklum balas kepada Banci Pertubuhan Pertanian Tahunan 2009 adalah sebanyak 4,885 dengan peratus taburan seperti di Carta 1. Subsektor yang mencatatkan bilangan pertubuhan tertinggi adalah tanaman iaitu 3,956 (81.0%) diikuti dengan ternakan 550 (11.3%) dan perikanan 379 (7.7%).

Peratus taburan pertubuhan mengikut negeri bagi tahun rujukan 2008 adalah seperti di Carta 2.

Negeri yang mempunyai bilangan pertubuhan tertinggi adalah Sabah berjumlah 1,027 (21.0%) diikuti dengan Johor dan Perak yang masing-masing mencatatkan 935 (19.1%) dan 653 (13.4%). Manakala bilangan pertubuhan terendah dicatatkan oleh Perlis (0.5%).

SUMMARY FINDINGS


1. DISTRIBUTION OF ESTABLISHMENTS

The total number of establishments engaged in the agriculture sector who responded to the Annual Census of Agricultural Establishments 2009 was 4,885 with percentage distribution as in Chart 1. The sub-sector which recorded the highest number of establishments was crops with 3,956 (81.0%) followed by livestock 550 (11.3%) and fisheries 379 (7.7%).

The percentage distribution of establishments by state for reference year 2008 is shown in Chart 2.

The state with the most number of establishments was Sabah totalling 1,027 (21.0%) followed by Johor and Perak recording 935 (19.1%) and 653 (13.4%) respectively. Meanwhile, the lowest number of establishments was recorded by Perlis (0.5%).

2. NILAI OUTPUT KASAR DAN NILAI DITAMBAH

Nilai output kasar yang dijana dari sektor pertanian pada 2008 adalah sebanyak RM38,379.5 juta dengan nilai ditambah berjumlah RM22,534.7 juta.


Subsektor tanaman adalah penyumbang nilai output kasar tertinggi iaitu 85.1 peratus diikuti oleh ternakan dan perikanan yang masing-masing mencatatkan 13.1 peratus dan 1.8 peratus. Nilai ditambah yang direkodkan bagi tanaman adalah sebanyak 96.1 peratus, ternakan 3.0 peratus dan perikanan 0.9 peratus.

2. VALUE OF GROSS OUTPUT AND VALUE ADDED

Value of gross output generated from the agriculture sector in 2008 was RM38,379.5 million with value added amounting to RM22,534.7 million.


The crops sub-sector was the main contributor to value of gross output at 85.1 per cent followed by livestock and fisheries with 13.1 per cent and 1.8 per cent respectively. The value added recorded for crops was 96.1 per cent, livestock 3.0 per cent and fisheries 0.9 per cent.

Ketiga-tiga subsektor menunjukkan peningkatan dalam nilai output kasar berbanding dengan tahun 2005 (Jadual A1) yang mana tanaman memonopoli sektor pertanian dan penyumbang utamanya adalah kelapa sawit (Jadual B1).

These three sub-sectors showed increases in the value of gross output when compared to 2005 (Table A1) where crops monopolised the agriculture sector which was mainly contributed by oil palm (Table B1).

3. GUNA TENAGA DAN GAJI & UPAH

Jumlah pekerja bergaji yang dilaporkan dalam sektor pertanian pada 2008 adalah seramai 330,058 yang menerima gaji & upah RM3,332.5 juta. Pekerja lelaki telah mendominasi sektor pertanian lebih tiga kali ganda berbanding pekerja perempuan. Jadual 1 menunjukkan bilangan pekerja lelaki melebihi perempuan dalam semua kategori pekerja kecuali Perkeranian.

3. EMPLOYMENT AND SALARIES & WAGES

The total number of paid employees engaged in the agriculture sector in 2008 was 330,058 who received salaries & wages amounting to RM3,332.5 million. Male employees dominated the agriculture sector by more than three times compared to female employees. Table 1 shows that the number of male workers exceeded females in all the categories except for the Clerical.

Pekerja buruh pertanian merupakan yang tertinggi sebanyak 277,642 orang atau 84.1 peratus dari jumlah pekerja bergaji. Ini menunjukkan pekerja buruh pertanian memainkan peranan penting dalam sektor pertanian.

Agricultural labour workers accounted for the highest number with 277,642 persons or 84.1 per cent of total paid employees. This portrayed that agricultural labour workers played an important role in the agriculture sector.

A. TABURAN

1. Mengikut Negeri

Sebanyak 3,956 pertubuhan yang terlibat dalam aktiviti tanaman pada 2008 telah menjawab kepada Banci Pertubuhan Pertanian Tahunan, 2009. Taburan pertubuhan mengikut negeri bagi subsektor tanaman adalah seperti di Carta 1.

Sabah merupakan negeri yang mempunyai bilangan pertubuhan tertinggi dalam subsektor tanaman iaitu 973 pertubuhan (24.6%) diikuti dengan Johor dan Perak yang masing-masing mencatatkan 746 (18.9%) dan 465 (11.8%). Bilangan pertubuhan yang terendah telah dicatatkan oleh negeri Perlis iaitu tiga pertubuhan (0.1 %) sahaja.

A. DISTRIBUTION


1. By State

A total of 3,956 establishments who were involved in the crops activity in 2008 responded to the Annual Census of Agricultural Establishments 2009. The distribution of establishments by state for the crops sub-sector is shown in Chart 1.

In the crops sub-sector, Sabah had the most number of establishments with 973 (24.6%) followed by Johor and Perak recording 746 (18.9%) and 465 (11.8%) respectively. The least number of establishments was recorded by the state of Perlis with only three establishments (0.1 %).

2. Mengikut Industri

Carta 2 menunjukkan peratus taburan bilangan pertubuhan mengikut industri bagi 2008.


Kelapa sawit mendominasi subsektor tanaman dengan sumbangan sebanyak 76.9 peratus manakala getah pula mencatatkan 5.0 peratus pada 2008. Ini menunjukkan kelapa sawit masih merupakan komoditi utama Malaysia.

2. By Industry

Chart 2 shows the percentage distribution of the number of establishments by industry for 2008.

Oil palm dominated the crops sub-sector with a share of 76.9 per cent whereas rubber recorded 5.0 per cent in 2008. This indicated that oil palm still prevailed as the main commodity in Malaysia.

B. NILAI OUTPUT KASAR

1. Mengikut Negeri

Pada 2008 nilai output kasar bagi tanaman adalah sebanyak RM32,668.4 juta.

Sabah merupakan penyumbang utama kepada nilai output kasar tanaman dengan jumlah sebanyak RM11,003.5 juta (33.7%) diikuti dengan Johor RM5,098.5 juta (15.6%) dan Pahang RM4,375.7 juta (13.4%). Ketiga-tiga negeri ini telah menyumbang sebanyak 62.7 peratus daripada jumlah nilai output kasar tanaman dan selebihnya adalah dari negeri-negeri lain.


B. VALUE OF GROSS OUTPUT

1. By State

The value of gross output for crops was RM32,668.4 million in 2008.

Sabah was the main contributor to the value of gross output for crops totalling RM11,003.5 million (33.7%) followed by Johor RM5,098.5 million (15.6%) and Pahang RM4,375.7 million (13.4%). These three states accounted for 62.7 per cent of the total value of gross output for crops while the balance was contributed by the other states.

2. Mengikut Industri

Jadual 1 menunjukkan nilai output kasar mengikut industri terpilih bagi tanaman. Sumbangan nilai output kasar tertinggi yang dicatatkan adalah daripada kelapa sawit dengan nilai sebanyak RM31,425.5 juta iaitu 96.1 peratus daripada jumlah nilai output kasar tanaman.

2. By Industry

Table 1 presents the value of gross output by selected industries for crops. The highest contribution recorded was from oil palm with a value of RM31,425.5 million and accounted for 96.1 per cent of the total value of gross output for crops.


C. NILAI DITAMBAH

Sejumlah RM21,644.8 juta nilai ditambah telah direkodkan pada 2008 daripada Banci ini. Sabah menyumbangkan nilai ditambah tertinggi iaitu sebanyak 35.4 peratus diikuti Johor dan Pahang yang masing-masing mencatatkan 14.0 peratus dan 13.3 peratus.

C. VALUE ADDED

A total of RM21,644.8 million was recorded as value added in 2008 from this Census. Sabah accounted for the highest value added with 35.4 per cent followed by Johor and Pahang which were 14.0 per cent and 13.3 per cent respectively.

D. GUNA TENAGA DAN GAJI & UPAH

Jumlah bilangan pekerja yang terlibat dalam subsektor tanaman adalah seramai 307,893 dengan bayaran gaji & upah sebanyak RM3,010.8 juta. Guna tenaga tertinggi dalam subsektor tanaman adalah dalam kategori pekerja buruh pertanian iaitu seramai 259,696 (84.3%). Bayaran gaji & upah pula bagi kategori ini adalah RM2,045.3 juta atau 67.9 peratus dan melebihi dua per tiga dari keseluruhan gaji & upah. Walau bagaimanapun, purata gaji sebulan yang dibayar kepada pekerja buruh pertanian hanyalah sebanyak RM656.

D. EMPLOYMENT AND SALARIES & WAGES

The total number of persons engaged in the crops sub-sector was 307,893 persons with RM3,010.8 million disbursed as salaries & wages. The highest employment in the crops sub-sector was in the agricultural labour workers category with 259,696 persons (84.3%). Salaries & wages that were paid out to this category amounted to RM2,045.3 million or 67.9 per cent which was more than two thirds of total salaries & wages. However, the average salaries per month paid to these agricultural labour workers was only RM656.



Sabah telah merekodkan bilangan guna tenaga tertinggi dalam subsektor tanaman jika dibandingkan dengan negeri-negeri lain iaitu seramai 127,292 pekerja (41.3%). Ini adalah selaras dengan taburan jumlah pertubuhan yang majoritinya terletak di negeri ini.

Sabah recorded the highest number of employees in the crops sub-sector with 127,292 persons (41.3%) when compared to the other states. This was in line with the distribution of the number of establishments where the majority were located in this state.

Perlis mencatatkan bilangan guna tenaga terendah kerana negeri ini kecil dan keluasan tanah adalah terhad.

Perlis recorded the least employment as this state is small with limited land area.


Carta 6 menunjukkan bilangan guna tenaga mengikut kategori bagi 2008. Data guna tenaga menunjukkan kebanyakan pekerja adalah pekerja sepenuh masa yang merangkumi 98.3 peratus dari jumlah guna tenaga.

Peratus penglibatan pekerja mengikut jantina bagi ketiga-tiga kategori mendapati pekerja lelaki meliputi 78.6 peratus hingga 83.6 peratus dari jumlah guna tenaga seperti dalam Carta 7.


Chart 6 shows employment by category for 2008. The employment data revealed that most of the employees were full-time workers accounting for 98.3 per cent of total employment.

The percentage involvement of employees by sex for the three categories showed that males accounted for 78.6 per cent to 83.6 per cent of total employment as shown in Chart 7.



E. LEGAL STATUS


In the crops sub-sector, 64.1 per cent of the establishments operated as private limited companies followed by individual proprietorship and public limited companies with 16.8 per cent and 10.2 per cent respectively. The distribution of establishments by legal status is shown in Chart 8.



TECHNICAL NOTES

NOTA TEKNIKAL

- 1. Pendahuluan** Banci Pertubuhan Pertanian telah dilaksanakan pada tahun 2009. Laporan ini memuatkan data berkaitan sektor pertanian bagi tahun rujukan 2008.
- 2. Objektif** Objektif utama banci adalah untuk mengumpul maklumat tentang pertumbuhan dan sumbangan pertubuhan dalam sektor pertanian. Data yang diperoleh boleh digunakan sebagai penanda aras bagi tujuan perancangan, penggubalan dasar serta penganalisisan sektor pertanian.
- 3. Kuasa perundangan** Banci ini dilaksanakan di bawah Akta Perangkaan 1965 (Disemak-1989). Seksyen 5 di bawah Akta ini menghendaki mana-mana pertubuhan yang beroperasi di Malaysia untuk memberikan maklumat sebenar atau anggaran terbaik kepada Jabatan. Mengikut Akta ini, kandungan soal selidik yang diterima adalah sulit dan hanya angka agregat diterbitkan.
- 4. Skop dan liputan** Meliputi pertubuhan yang terlibat dalam sektor pertanian. Liputan banci terdiri daripada 30 industri di peringkat 5-digit dan 5 kumpulan di peringkat 3-digit yang dikelaskan sebagai Kategori A dalam *Malaysia Standard Industrial Classification (MSIC), 2000*. Senarai lengkap industri yang diliputi ditunjukkan dalam **Lampiran**.
- 5. Rangka (sumber)** Banci ini meliputi pertubuhan berdaftar yang terlibat dalam industri pertanian. Sumber maklumat utama rangka pertubuhan diperoleh daripada Suruhanjaya Syarikat Malaysia (SSM). Maklumat rangka banci juga dikemaskini daripada sumber seperti Jabatan/agensi di bawah Kementerian Pertanian dan Industri Asas Tani, Kementerian Perusahaan Perladangan dan Komoditi dan pelbagai persatuan perniagaan dan perdagangan, iklan surat khabar serta laman web. Rangka dikemas

kini setiap tahun untuk mengambil kira pertubuhan baru dan sebarang perubahan seperti tutup, tidak beroperasi, perubahan jenis aktiviti atau alamat pos.

6. Metodologi

Banci ini dijalankan secara mel menggunakan borang soal selidik. Responden diberi tempoh satu bulan untuk melengkap dan mengembalikan borang soal selidik tersebut kepada Jabatan ini. Selepas tempoh tersebut, kerja luar dijalankan untuk mendapatkan borang lengkap daripada pertubuhan yang tidak respon.

7. Unit pelapor

Unit pelapor bagi binci ini ialah **pertubuhan**. Sesebuah pertubuhan secara ideal ditakrifkan sebagai “satu unit ekonomi yang bergiat di bawah satu hak milik atau penguasaan tunggal, iaitu di bawah satu entiti yang sah. Ia menjalankan satu jenis subsektor ekonomi utama di satu tempat/lokasi fizikal”. Setiap pertubuhan diberikan klasifikasi industri berdasarkan subsektor utamanya. Setiap cawangan daripada organisasi yang mempunyai beberapa cawangan di lokasi yang berbeza dari segi konsep dianggap sebagai pertubuhan yang berlainan. Pertubuhan berkenaan diminta memberikan penyata yang berasingan bagi setiap kegiatannya dari segi nilai. Walau bagaimanapun, dari segi praktis akaun biasanya disediakan secara berpusat kerana kesukaran untuk memperoleh data yang berasingan bagi setiap unit atau cawangan. Entiti atau ‘*enterprise*’ ini akan dianggap sebagai satu unit pelapor dan dibenarkan mengemukakan soal selidik yang menggabungkan semua unit atau cawangannya. Konsep pertubuhan dalam sektor pertanian biasanya merujuk kepada ladang.

8. Tahun binci

Tahun binci merujuk kepada tahun pelaksanaan binci. Laporan ini merujuk kepada data tahun 2008.

9. Tempoh rujukan	Tempoh rujukan bagi binci ini ialah tahun takwim 2008. Pertubuhan yang mempunyai tahun perakaunan yang berbeza daripada tahun takwim diminta menyediakan laporan mengikut tahun perakaunan atau kewangan yang meliputi sebahagian besar daripada tahun rujukan.
10. Jenis aktiviti perniagaan	Jenis aktiviti perniagaan merujuk kepada aktiviti utama dan sekunder. Aktiviti utama merujuk kepada aktiviti yang mana pertubuhan menggunakan sebahagian besar daripada sumbernya atau ia sebagai punca perolehan pendapatan yang tinggi. Aktiviti sekunder didefinisikan sebagai aktiviti sampingan kepada aktiviti utama. Klasifikasi industri bagi pertubuhan adalah mengikut aktiviti utamanya berdasarkan <i>MSIC 2000</i> . <i>MSIC 2000</i> adalah selaras dengan <i>International Standard Industrial Classification of All Economic Activities (ISIC), Rev. 3, United Nations</i> .
11. Konsep dan definisi	Konsep dan definisi yang diguna berasaskan kepada syor-syor Pejabat Perangkaan Pertubuhan Bangsa-Bangsa Bersatu. Konsep berkenaan mengikut amalan yang sudah diterima pakai bagi memudahkan perbandingan data dibuat di peringkat antarabangsa.
12. Takrif pertanian	Pertanian merangkumi pembiakan baka, pemeliharaan atau penanaman semua jenis haiwan atau sayuran kecuali pepokok hutan dan kehidupan laut. Perkhidmatan pertanian dan penternakan haiwan seperti pembersihan tanah, merumput, penyemburran racun dan lain-lain adalah turut termasuk dalam kategori ini.
	Tanaman jangka panjang (<i>bio-assets</i>) adalah tanaman yang mengeluarkan hasil berulang kali dan mempunyai jangka hayat lebih dari setahun (cth. kelapa sawit, getah, durian, dll.)

i. Tanaman matang

Tanaman yang telah mencapai peringkat umur untuk dituai atau mengeluarkan hasil.

ii. Tanaman belum matang

Tanaman yang belum mencapai peringkat umur untuk dituai atau belum boleh mengeluarkan hasil.

iii. Perbelanjaan pembangunan tanaman belum matang

Meliputi semua perbelanjaan ke atas tanaman belum matang sahaja sama ada tanaman baru atau tanaman semula (cth. pembersihan kawasan, baja, racun, upah dan lain-lain).

13. Taraf sah

Taraf sah sesebuah pertubuhan telah ditakrifkan seperti berikut:

i. Hak milik perseorangan

Ia merujuk kepada perniagaan yang dimiliki dan dijalankan oleh orang perseorangan semata-mata untuk mendapatkan keuntungan sendiri. Pemilik mempunyai hak mutlak atas segala urusan pertubuhannya.

ii. Perkongsian

Ia merujuk kepada sekumpulan individu yang telah bersetuju mengikat kontrak dan menjalankan perniagaan dengan matlamat untuk memperoleh keuntungan. Perniagaan tersebut diuruskan oleh kesemua mereka atau salah seorang daripada mereka yang bertindak mewakili semua pihak. Perkongsian perniagaan ini hendaklah mengandungi sekurang-kurangnya dua orang ahli dan tidak melebihi had maksimum dua puluh orang.

iii. Syarikat sendirian berhad

Ia merupakan sebuah perbadanan swasta yang ditubuhkan untuk menjalankan perniagaan dengan

matlamat untuk mencari keuntungan. Saham dipegang secara tertutup (*closely held*) oleh pemegang saham yang mempunyai kawalan terhadap operasi syarikat. Ia didaftarkan dengan tanggungan berhad (*with limited liability*).

Sesebuah syarikat sendirian berhad mempunyai Memorandum dan Artikel Persatuan sendiri, yang antara lain:

- a) menghadkan hak untuk memindahkan sahamnya;
- b) menghadkan bilangan pemegang saham di antara dua hingga lima puluh orang (tidak termasuk pekerja syarikat itu dan bekas pekerja yang masih menjadi ahli);
- c) melarang sebarang pelawaan kepada orang ramai untuk membeli apa-apa saham atau debentur syarikat itu; dan
- d) melarang sebarang pelawaan kepada orang ramai supaya menyimpan wang di syarikat itu bagi sesuatu tempoh yang ditetapkan atau boleh dibayar apabila dituntut, dengan atau tanpa faedah.

iv. Syarikat awam berhad

Ia merupakan sebuah perbadanan swasta yang ditubuhkan, dengan tanggungan terhad, oleh sekurang-kurangnya dua orang untuk menjalankan perniagaan dengan tujuan untuk mencari keuntungan. Saham syarikat awam berhad ini dipegang secara terbuka (*openly held*) dan bagi sesebuah syarikat yang disenaraikan di bursa saham, sahamnya boleh bertukar milik secara bebas. Syarikat tersebut dianggap sebagai sebuah entiti yang sah dan ditubuhkan mengikut Memorandum dan Artikel Persatuan.

v. Koperasi

Ia merujuk kepada sesebuah persatuan sukarela yang bilangan ahlinya tidak terhad dan didaftarkan di bawah Akta Koperasi 1993. Kumpulan wang yang ada adalah milik bersama untuk memenuhi keperluan ahli-ahlinya.

vi. Perbadanan awam

Ia merupakan sebuah perbadanan yang ditubuhkan di bawah Akta Khas Parlimen atau Dewan Perundangan Negeri.

vii. Lain-lain

Ia merujuk kepada semua pertubuhan lain yang tergolong di bawah mana-mana kategori yang tersebut di atas.

14. Hak milik

Hak milik sesebuah pertubuhan dikelaskan mengikut taraf pemastautin pemilik/pemilik-pemilik modal berbayar yang terbesar (melebihi 50 peratus) dan bukannya mengikut taraf kerakyatan mereka. Dalam kes di mana setiap pihak (Pemastautin Malaysia atau Bukan Pemastautin Malaysia) memegang jumlah saham yang sama banyak dalam perniagaan berkenaan, pertubuhan itu dikelaskan di bawah ‘Hak Milik Bersama’.

Pemastautin Malaysia ialah individu, syarikat atau organisasi lain yang lazimnya terletak di Malaysia untuk jangka masa sekurang-kurangnya satu tahun. Cawangan dan anak syarikat asing yang didaftarkan/diperbadankan di Malaysia adalah dianggap sebagai pemastautin Malaysia.

Bukan pemastautin Malaysia ialah individu, syarikat atau organisasi lain yang lazimnya terletak di negara selain Malaysia. Cawangan dan anak syarikat milik pemastautin Malaysia di luar negeri juga dianggap sebagai bukan pemastautin Malaysia.

15. Jumlah pekerja

Jumlah pekerja merujuk kepada bilangan orang yang bekerja pada bulan Disember atau pada tempoh pembayaran gaji terakhir bagi tahun rujukan. Bilangan orang yang bekerja dikategorikan seperti berikut:

i. Pemilik yang bekerja dan rakan niaga yang aktif

Kategori ini merujuk kepada semua pemilik perseorangan dan rakan niaga, sambilan atau sepenuh masa, yang bekerja dengan aktif dalam ses sebuah pertubuhan itu. Justeru, ia tidak termasuk rakan niaga yang tidak aktif.

ii. Pekerja keluarga tidak bergaji

Ia ditakrifkan sebagai semua ahli isi rumah kepada pemilik pertubuhan yang melaksanakan kerja tertentu (sepenuh masa atau sambilan) dan bekerja sekurang-kurangnya satu pertiga daripada waktu bekerja biasa yang diamalkan oleh pertubuhan berkenaan tanpa mendapat bayaran secara tetap, sama ada dalam bentuk wang tunai atau harta benda bagi kerja yang dilakukan. Biasanya pekerja berkenaan mendapat makanan, tempat tinggal dan bantuan lain sebagai sebahagian daripada ahli isi rumah pemilik tersebut dan terus mendapatnya sama ada ia bekerja atau tidak di dalam pertubuhan itu.

iii. Pekerja sepenuh masa

Ia ditakrifkan sebagai semua pekerja bergaji yang bekerja sekurang-kurangnya enam jam sehari dan sekurang-kurangnya 20 hari sebulan.

iv. Pekerja sambilan

Ia ditakrifkan sebagai semua pekerja bergaji yang bekerja kurang daripada enam jam sehari dan/atau kurang daripada 20 hari sebulan.

16. Gaji & upah dibayar	ia merujuk kepada emolumen kasar yang dibayar kepada pekerja sepanjang tahun rujukan termasuk gaji, upah, bonus, komisen, bayaran lebih masa, bayaran pampasan dan elaun lain sebelum ditolak sumbangan pekerja kepada Kumpulan Wang Simpanan Pekerja (KWSP), Pertubuhan Keselamatan Sosial (PERKESO) atau sumbangan lain. Tidak termasuk elaun kepada pemilik yang bekerja, rakan niaga yang aktif dan pekerja keluarga tidak bergaji.
17. Nilai harta	Harta meliputi semua barang, baru atau terpakai, aset ketara dan aset tidak ketara yang mempunyai hayat produktif lebih daripada setahun (seperti tanah, bangunan, jentera dan alat kelengkapan, termasuk kelengkapan pengangkutan). Nilai yang dilaporkan adalah nilai seperti pada penghujung tahun rujukan dan mengikut buku akaun unit pelapor. Ia termasuk perolehan baru sepanjang tahun berkenaan tetapi tidak termasuk harta yang dilupuskan pada tahun tersebut. Ia adalah nilai bersih setelah ditolak susut nilai.
18. Perbelanjaan modal	Merujuk kepada nilai belian dan akaun harta tetap bagi pembinaan sendiri sepanjang tahun rujukan. Selain itu, pengubahan dan penambahbaikan ke atas harta sedia ada yang dapat melanjutkan masa sesuatu ekonomi atau meningkatkan sesuatu produktiviti juga termasuk dalam definisi ini.
19. Aset pertanian	Aset pertanian merujuk kepada semua pokok/tanaman, ternakan dan perikanan akuakultur yang dijangka mempunyai jangka hayat lebih daripada satu tahun dan boleh mengeluarkan hasil yang berterusan atau berulang-ulang.
20. Nilai output kasar	Nilai output kasar pertanian (tanaman, ternakan dan perikanan) meliputi: <ul style="list-style-type: none"> + Jualan daripada hasil pertanian - Stok hasil pertanian (awal)

- + Stok hasil pertanian (akhir)
- + Pendapatan daripada kerja pertanian yang dibuat untuk pihak lain
- + Pendapatan daripada hasil pertanian yang diproses
- + Nilai jualan daripada barang/bahan/produk berkaitan pertanian yang dibeli untuk dijual semula tanpa melalui proses selanjutnya
- + Pendapatan lain yang berkaitan dengan pertanian
- + Pendapatan daripada aktiviti pertanian lain
- + Pendapatan daripada sewa
- + Pendapatan daripada agro pelancongan
- + Nilai jualan barang bukan pertanian yang dibeli untuk dijual semula
- Kos barang/bahan/produk berkaitan dengan sektor pertanian yang dibeli untuk dijual semula tanpa melalui proses selanjutnya
- + Semua nilai output lain
- Barang dalam proses dan stok barang siap (awal)
- Kos barang yang dijual (bukan pertanian) yang dibeli untuk dijual semula
- + Barang dalam proses dan stok barang siap (akhir)

21. Kos input

Kos input meliputi:

- + Kos bahan langsung yang digunakan dalam sektor pertanian
- + Jumlah bayaran ke atas kerja-kerja pertanian yang dibuat oleh pihak lain
- + Kos biji/benih tanaman jangka pendek/ternakan bukan baka bagi haiwan dan perikanan
- + Bahan dan bekas pembungkusan yang digunakan
- + Bahan yang digunakan bagi pembaikan dan penyelenggaraan
- + Alat tulis dan bekalan pejabat yang digunakan
- + Tenaga elektrik yang dibeli
- + Air yang dibeli

- + Bahan pembakar, pelincir dan gas yang digunakan
- + Bayaran pembaikan dan penyelenggaraan semasa yang dibuat oleh pihak lain bagi harta tetap pertubuhan ini
- + Bayaran terhadap perkhidmatan bukan industri pertanian

TECHNICAL NOTES

1. Introduction

Census of Agricultural Establishments was conducted in 2009. This report provides data on the agriculture sector for reference year 2008.

2. Objective

The main objective of the census is to collect information pertaining to the growth and contribution in the agriculture sector. The data obtained could be used as a bench mark for planning, formulation of policies as well as analysis of the agriculture sector.

3. Legal authority

The survey was conducted under the provisions of the Statistics Act, 1965 (Revised 1989). Section 5 of this Act requires all establishments operating in Malaysia to provide actual information or best estimates to the Department. The Act stipulates that the contents of the individual returns received are confidential and only aggregated figures are published.

4. Scope and coverage

Refers to establishments involved in agriculture. The coverage of the census included 30 industries at 5-digit level and 5 groups at 3-digit level classified under the Malaysia Standard Industrial Classification (MSIC), 2000. A full list of industries covered is shown in Appendix.

5. Frame (source)

The census covered registered establishments engaged in the agricultural industry. The main source of information for the frame is the Companies Commission of Malaysia (CCM). The census frame was also updated from other sources such as the departments/agencies under the Ministry of Agriculture and Agro-Based Industry, Ministry of Plantation Industries and Commodities and various businesses and trade associations, newspaper advertisements as well as websites. The frame is updated annually to take into account new establishments and to record any

changes in the status of the establishments such as closed down, not in operation, change in activities and location or postal addresses.

6. Methodology

The census was primarily conducted through mail enquiry. Respondents were given one month to complete and return the questionnaires to the Department after which, field enumeration was undertaken to get the completed questionnaire from the establishments that did not respond.

7. Reporting unit

The reporting unit used in the census was the establishment. An establishment is defined as “an economic unit engaged in one activity, under a single legal entity and operating in a single physical location”. Each establishment was assigned an industry classification based on its principal activity. Thus, each branch of a multi-branch organization at a different location was conceptually treated as a different location establishment. The establishment is requested to give separate returns for each sub-sector in terms of value. However, if in practice, the accounts were centrally kept such that it was not possible to obtain separate data for each individual unit or branch, the entity or enterprise was treated as a single reporting unit and allowed to submit a consolidated questionnaire covering all the units or branches. In the agriculture sector, the concept of establishment usually refers to a farm.

8. Census year

Census year refers to the year in which the census was conducted. This report refers to data for 2008.

9. Reference year

The reference period for this census was the calendar year 2008. Establishments whose accounting year differed from the calendar year were requested to

report according to the accounting or financial year covering the major part of the reference year.

10. Type of business activity

The type of business activity refers to both the principal and secondary activities. The principal activity refers to the activity to which the establishment devoted most of its resources or to which it derived most of its income. Secondary activities are defined as those incidental or ancillary to the principal activity. The classification of the industry of the establishment is based on its principal activity and is in accordance with MSIC 2000. The MSIC 2000 conforms to the International Standard Industrial Classification of All Economic Activities (ISIC) Rev.3, United Nations.

11. Concepts and definitions

Concepts and definitions used are based on the recommendations of the United Nations' Statistical Office. These concepts adhere to accepted practices, thereby facilitating international comparability of data.

12. Definition of agriculture

Agriculture includes the breeding, keeping cultivation of all kinds of animal or vegetable life except forest trees and marine life. Agriculture and animal husbandry services such as land clearing, weeding, pests spraying, etc. are also included in this category.

Perennial crops (bio-assets) are crops that produce products repeatedly and have a life expectancy of more than one year (e.g. commodity crops, fruits)

i. Matured crops

Crops that have reached maturity period and are ready for harvesting or generate production.

ii. Immatured crops

Crops that have not reached maturity period and are not ready for harvesting or generate production.

iii. Development expenditure for immature crops

Include all expenses for immature trees whether newly planted or replanted (e.g. clearing the area, fertilizers, pesticides, wages etc.)

13. Legal status

For the purpose of this census, the legal status of an establishment has been defined as follows:

i. Individual proprietorship

This refers to a business, owned and operated by one person for his own profit. The owner has the exclusive right to control the operation of the establishment.

ii. Partnership

This refers to a group of individuals who agree to contract and to carry on a business with the objective of making a profit. All shareholders or any one could manage the business for all parties. A trading partnership must comprise of at least two members and should not exceed a maximum of twenty members.

iii. Private limited company

This is a private corporation established to undertake a business with the objective of making a profit. The shares are closely held by the shareholders of the corporation who have control over its operation. It is registered with limited liability.

A private limited company has its Memorandum and Articles of Association, which among others:

- a) restricts the right to transfer its share;
- b) limits the number of its shareholders between two to fifty persons (not including employees of the company and ex-employees who are currently members);

- c) prohibits invitation to the public to subscribe for any shares or debentures of the company; and
- d) prohibits any invitation to the public to deposit money with the company for fixed periods or payable at call without interest.

iv. Public limited company

A public limited company is also a private corporation established, with limited liability, by a minimum of two persons to operate the business with the objective of making a profit. The shares in a public limited company are openly held, and in the case of a company listed on the stock exchange, the shares are freely transferable. The company is regarded as a legal entity and is constituted by the Memorandum and Articles of Association.

v. Co-operative

This refers to a voluntary association with an unrestricted number of members and registered under the Co-operative Act 1993. Funds are collectively owned to meet the needs of members.

vi. Public corporation

This refers to an undertaking set up under a Special Act Parliament or by the State Legislature.

vii. Others

It refers to all other establishments, which do not fall under any of the categories mentioned above.

14. Ownership

The ownership of an establishment is classified by the residential status of the owner (s) of the majority (more than 50 per cent) of the paid-up capital and not by their citizenship status. In cases where each party (Malaysian Residents and Non-Malaysian Residents) held equal shares in the business, the establishment is classified under 'Joint-Ownership'.

A **Malaysian resident** is any individual, company or other organization ordinarily domiciled in Malaysia for a period of at least one year. Malaysian registered branches and incorporated subsidiaries of foreign based/origins are also regarded as residents.

A **non-Malaysian resident** is any individual, company or other organization ordinarily domiciled in a country other than Malaysia. Foreign branches and/or subsidiaries abroad owned by residents are also regarded as non-residents.

15. Number of persons engaged

Number of persons engaged refers to all persons working during December or the last pay period of the reference year. The number of persons engaged was classified under the following categories:

i. Working proprietors and active business partners

This category refers to all individual proprietors and partners, part-time or full-time, who are actively engaged in the work of the establishment. It therefore excludes silent and inactive partners.

ii. Unpaid family workers

This is defined as all persons (full-time or part-time) of the household of any of the owners' of the establishment who perform a specified job and work for a minimum of one third of the normal working time of the establishment, but do not receive regular payments either in cash or in kind for the work done. Such workers generally receive food, shelter and other support as part of the household of an owner but these provisions would continue whether they work in the establishment or not.

iii. Full-time employees

This is defined as all paid workers who work for at least six hours a day and for at least 20 days a month.

iv. Part-time employees

This is defined to include all paid workers who work for less than six hours a day and/or less than 20 days a month.

16. Salaries & wages paid *This refers to gross emoluments paid to employees during the reference year, inclusive of salaries, wages, bonuses, commission, overtime pay, dismissal pay and other allowances before deduction of employees' contribution to Employees Provident Fund (EPF), Social Security Schemes (SOCSO) or any other deductions. Allowances to working proprietors, working partners and unpaid family workers are not included.*

17. Value of assets *Assets cover all goods, new or used, tangible or intangible, which have a normal economic life span of more than one year (e.g. land, building, machinery and equipment, including transport equipment). The value reported is as at the end of the reference year and is according to the books of accounts of the reporting unit. It includes additions during the year and excludes assets disposed off during the year. It is net of depreciation.*

18. Capital expenditure *Refers to the value of purchases and own-account construction of fixed assets during the year. Major additions, alterations and improvements to existing assets that extend their normal economic life or raise productivity are also included in this definition.*

19. Agricultural assets *Cultivated assets refer to trees/crops, livestock and aquaculture fishing which are expected to have a*

productive life of more than one year and able to produce continuously or repeatedly.

20. Value of gross output *The value of gross output agriculture (crops, livestock and fisheries) includes:*

- + *Sales of agriculture product*
- *Stocks of agricultural products (opening)*
- + *Stocks of agricultural products (closing)*
- + *Income from agricultural work done for others*
- + *Income from processed agricultural products*
- + *Value of sales from goods/materials/products related to agriculture that is purchased for resale without further processing*
- + *Other income related to agriculture*
- + *Income from other agricultural activities*
- + *Rental income received*
- + *Income received from agro tourism*
- + *Value of sales from non-agricultural goods that is purchased for resale*
- *Cost of goods/material/products purchased for resale without undergoing further processing*
- + *All other output value*
- *Goods in progress and stocks of finished goods (opening)*
- *Cost of goods sold (non-agricultural) that is purchased for resale*
- + *Goods in progress and stocks of finished goods (closing)*

21. Cost of input

Cost of input includes:

- + *Cost of direct materials consumed in agriculture*
- + *Total payment on agricultural work done by other establishments*
- + *Cost of non-perennial crops seeds/non-breeder livestock and fisheries*
- + *Packing materials consumed*
- + *Materials used for repairs and maintenance*

- + *Stationery and office supplies consumed*
- + *Electricity purchased*
- + *Water purchased*
- + *Fuel, lubricants and gas consumed*
- + *Payments for current repairs and maintenance work done by others on this establishment's fixed assets*
- + *Payments for non-agricultural industrial services*
- + *Expenditure on other agricultural activities*
- + *Research and development expenditure*
- + *Expenses on agro tourism*
- + *Royalties paid to private (others)*
- + *Royalties paid to private (technology licensing)*
- + *Other input values*
- + *Fees paid to non-working directors for their attendance at Board of Directors' meetings*

22. Value added

Value added is derived as the difference between the value of gross output and the cost of input.

23. Rounding

The sum of components may not add up to the totals in the tables presented in this publication due to rounding.
