It is composed of a series of 6 workshops, namely: service vision and values; service audit; basic customer service skills; service improvement; celebrating accomplishments; and, ethics and accountability. Each workshop has its own set of objectives, activities and outputs. The PSEEAP will cover critical departments to be identified by the LGU. Critical departments are those that the LGU considers as having regular and significant interaction with citizenry or constituents. The PSEEAP runs from between 6 and 12 months depending on the pace and availability of LGU participants, particularly department heads.

The objectives of IDR is to identify measures that will safeguard key LGU systems and processes against corruption. It seeks to assess the level of corruption resistance of current LGU systems based on certain standards of organizational integrity; and to examine high-risk activities and/or functions of the LGU where corruption could occur, and assess the probability that corruption occurs or will occur and not be prevented or detected in a timely manner by the internal controls/ systems in place.





This effort is expected to help prevent the incidence of corruption in LGU administration, management and service delivery, and to promote a culture of integrity and excellence in local governance.

The IDR is an integrity enhancement measure that aims to build institutional foundations to prevent corruption before it occurs. It has two (2) parts – the corruption resistance review (CRR) which provides a quick sum of integrity building measures used by the agency (LGU) in the policies and operations; and the corruption vulnerability assessment (CVA) which examines the operations of the LGU and assess probability of corruption and existence of internal controls.

Report Card Survey of Public Services utilizes the level of citizens' satisfaction (or dissatisfaction) as a gauge to rate government performance on a particular function or set of mandated functions. Clients of public offices/agencies rate the quality of the services across several dimensions of their actual experience and/or contact with the service(s), which include their awareness, convenience, and level of satisfaction. Accounting for the services' indirect costs, the survey also ascertains the price of these services, given the clients' experience with rent seeking, their prescribed alternatives, and willingness to pay for the improvement of services.

Flood forecasting and warning is one of the major operational services of PAGASA-DOST. This is implemented in major river basins in the country, however, in smaller river basins, the PAGASA is currently promoting the establishment of community based flood early warning system (CBFEWS). The CBFEWS is a cheap, non-structural, flood mitigating measure that empowers the community to plan and act accordingly in the event of a flood. It is a scheme that integrates institutions, instrumentation, and the LGUs and community where the LGUs and community are trained to install rainfall and water level gauges, observe and analyze data and transmit to a Disaster Operation Center in the barangay or municipality. The LGUs will also learn how to issue the appropriate levels of flood advisories in the form of Ready, Get Set, and Go warnings, respectively, and which are designed to prepare, alert and enable the communities at risk to respond.


